Please be considerate of other crafters who will be moving in and out at the same time. In other words, unload your items, move your vehicle, and then set up your booth.
5. **You must provide your own tables and displays. Chairs will be available for you to use if you wish.**
6. **Absolutely no packing up until 3 PM!** We reserve the right to refuse future registrations with no refunds if you pack up before closing time.
7. All vendors are required by NJ State law to collect and submit sales tax, and display their sales tax certificate in their booth.
8. Please enclose a copy of your insurance certificate, if available.
9. Spaces are limited. Please complete the form below as soon as possible and mail along with your check made payable to **GTAMA** to the address above. **YOUR CANCELED CHECK IS YOUR ONLY RECEIPT.**
10. **GTAMA reserves the right to ask for items to be removed from displays which we feel are hazardous or offensive. Please keep in mind that this is a family-oriented event, so please use good discretion.**
